There will be roughly 4.3 billion urban dwellers by 2025, and each one will produce 1.42 kg of rubbish each day on average. Yusuf and Adesola, looked into how much people benefited from federal government spending on solid waste management. The report showed that the poor benefit from around 63% of all government spending on solid waste management, although the moderately poor are disproportionately favored.
